## Valentine's Day Fudge

### Ingredients

- 3 3/4 White Chocolate Chips
- 14 ounce can Sweet Condensed Milk
- 1 teaspoon Vanilla Extract
- 1/2 cup Sprinkles

### Instructions

- Line a 9×9 square pan with parchment paper that covers the sides of the pan.
- Place the white chocolate chips and sweetened condensed milk in a large bowl and microwave for one minute. Stir well to combine and allow the heat to melt the chocolate chips. If needed, microwave for another 30 seconds or so, until the chocolate is completely smooth.
- Stir in the vanilla extract and 1/4 cup of sprinkles, then quickly transfer the mixture to the lined pan and spread evenly.
- 4. Top the fudge with the remaining sprinkles and press them down into the top of the fudge.
- 5. Refrigerate the fudge until it's completely cool and firm.
- 6. Cut the fudge into squares and store in an air tight container. Fudge can be stored at either room temperature or in the fridge.





## "February Birthdays"

- February 1, 1878 Hattie Caraway the first woman elected to the U.S. Senate, was born in Bakersville, Tennessee. Her husband became the *U.S. Senator* from Arkansas. Following his death in 1931, she filled the remainder of his term, then was elected herself, serving a total of 14 years.
- President, was born in Tampico, Illinois. Reagan spent 30 years as an entertainer in radio, film, and television before becoming governor of California in 1966. Elected to the White House in 1980, he survived an assassination attempt and became the most popular president since Franklin Roosevelt.
- February 15, 1820 Susan B. Anthony was born in Adams, Massachusetts. A pioneer in women's rights, she worked tirelessly for woman's suffrage (right to vote) and in 1872 was arrested after voting (illegally) in the presidential election. She was commemorated in 1979 with the Susan B. Anthony dollar coin, thus became the first American woman to have her image on a U.S. coin.
- February 23, 1904 Historian William L. Shirer was born in Chicago, Illinois. As a news reporter stationed in Europe, he witnessed the rise of **Adolf Hitler** and reported on the surrender of France. Following the war he wrote the first major history of Nazi Germany, *The Rise and Fall* of the Third Reich.
